- With trusted service providers that assist in operating our Services (e.g., hosting, payment processing)
- As required by law, legal process, or to protect our rights

4. Data Retention

We retain your data only for as long as necessary to provide our Services or to comply with legal, regulatory, or club-related obligations.

5. Security

We implement reasonable administrative, technical, and physical safeguards to protect your information. However, no method of transmission over the internet or mobile networks is 100% secure.

6. Children's Privacy

Our Services are not directed to children under 13, and we do not knowingly collect personal information from them. If we learn that we have collected such information, we will take steps to delete it promptly.
